At the end of the school year we host a time where parents and students coming into kindergarten come in a familiarize themselves with the building and learn about school readiness and academic expectations for kindergarten. In October we have conferences with each family about their students academic needs. We host parent nights throughout the year to give parents ideas how to involve themselves in their students reading or math education for all grade levels.
